## **GENERAL CONDITIONS OF SALE**

The following general conditions of sale are understood to be accepted with the signature of the Order.

CONTRACTdesign carries out surveys on site and design free of charge but this is purely as a suggestion, CONTRACTdesign is not responsible for the survey and the project, the customer who signs this order is responsible for the measurements and shapes of the furniture as well as described in the order.

The BALANCE of the furniture must be paid by the customer upon delivery and control of the quantity of the furniture but before starting the unpacking, positioning on the shelves and assembly works. Only the share of the assembly costs can be paid later.

The final test is countersigned between the CUSTOMER and the CONTRACTdesign at the end of the assembly with fitters on site who will resolve any anomalies at the same time. The test is unique and unrepeatable, no complaints made after testing are accepted. The acceptance test must contain the declaration of delivery in accordance with the order and state-of-the-art assembly. The test will also contain the notes and anomalies found which will be fixed by CONTRACTdesign within a maximum of 2 weeks and will not have any cost for the CUSTOMER as they will be considered under WARRANTY. The guarantee starts and is effective only upon signing of the positive test and after settlement.

The delivery date can be postponed by the customer if the yard is not ready to receive the furnishings within a maximum of 15 days before the date set for delivery. If the delivery is postponed in the last 15 days, penalties will be charged by the assembly teams and by the hauliers.
